NOTICE OF PUBLIC MEETING

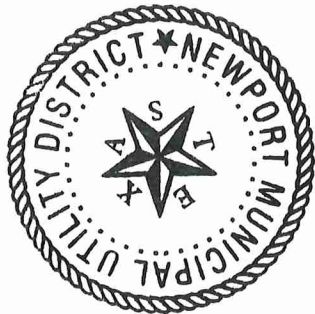


The meeting will be held at **3:00 p.m. on Thursday, May 16, 2019.**
